HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the "Releasees" from all liability to the undersigned my/our personal representatives, assigns, heirs and next of kin for any and all loss or damage and any claim or demand on account of any injury to the participant included, but not limited to, death whether caused by the negligence of the "Releasees" or otherwise while the minor is in or upon the restricted area and/or competing, officiating in, observing, working or for any purpose participating in the event.
